Comments:

Mahalo for the opportunity to support this measure. May I suggest that language be inserted to state that when the distance of 750 feet touches upon parks, public housing complexes etc., that the whole of said complex/amenity be included automatically. In the instance of Kahalu'u Elementary School, as an example, this would then include the entirety of nearby Kahalu'u Regional Park, down-to and surrounding the Flood Control Lagoon. This area was recently in the news in relation to sales of over an ounce of meth to an undercover officer - a joint sting by HPD and the FBI. Language should also be considered to include Community/Civic Centers within the same distance, or touched upon, where youth programs and/or education in affiliation with the State Dept. of Education takes place. Again, in the Kahalu'u area example, this would automatically include KEY Project, where we hold classes in conjunction with Windward School for Adults; non-school hour programs for elementary-aged youth, teens etc.
