SB 2793, RELATING TO THE HAWAIIAN HOMES COMMISSION ACT

Chair Galuteria, Vice-Chair Ryan and Members of the Committee:

The Department of Hawaiian Home Lands strongly supports SB 2793, which allows for the suspension of administrative rules for the purpose of awarding a lease to a native Hawaiian who has been on the waitlist for at least 20 years. This bill is part of the Governor's administrative package by request of our department.

As the department develops varied homestead products to immediately meet the current needs of its longest-waiting applicants, the ability to suspend the department's administrative rules can eliminate barriers that have prevented Hawaiian Home Lands applicants from receiving a homestead lease. Of the 21,151 residential applicants, 6,740 have been on the waiting list for at least 20 years. This measure targets nearly one-third of the native Hawaiians who are waiting for a lease and who may otherwise never be able to accept a lease award.

The Office of Hawaiian Affairs (OHA) offers the following comments on SB2793, which would allow the chairman of the Department of Hawaiian Homelands (DHHL), with unanimous consent of the commission, to suspend administrative rules and award a lease to a beneficiary who has been on the waitlist for at least twenty years.

Our primary observation is that the bill could greatly benefit from further details to support its main proposal. For example, the justification for the bill indicates that the waiver would allow DHHL to provide beneficiaries with access to new products it is developing. However, the bill itself does not explain when and how the waiver can be used. The bill is also silent regarding other significant details. Therefore, we recommend that the following points be addressed in either the preamble, the body of the bill, or through rule making:

- How DHHL will justify choosing between multiple beneficiaries who have been applicants for more than twenty years.
- Why twenty years is the operative cut-off date.
- That the waiver is meant to facilitate the placement of families into new DHHL products such as multi-generational housing (if that is, in fact, the intent of the waiver).

We understand the direction of this legislative body in the placing of the (n) ative Hawaiians with sub-standard provisional housing (HB 2634) and with the progenitor of these events the "Kauhale Pilot Program" would validate this particular measure. Granted Commissioner Chairman Alapaki Nahale-a has federal administrative powers on Hawaiian Home Lands **Trust**, so we don't understand that he has to have permission from the state to administer an assigned lot to a (n) ative Hawaiian/beneficiary. It's not that the government has permission to incorporate its egregious rules on the (n) ative Hawaiian (section 206 of the HHCA say otherwise,) it's that the Territory of Hawaii were given a **trust** to incorporate into the Admission Act (Public Law 86-3) for the privilege of unification with the Union and not administrate its rules on HHCA (DHHL pilfer Public, no. 34 STAT 108 chapter 42 in 63' that incorporate a federal program into its system, changed the rules, and began the encumbrance directives of assets.) So we feel there's a two tier system management being created within this measure for the Chair of the Commission with engagement of an ambiguous system to accommodate the (n) ative Hawaiian. We continue to see and hear our families and friends voice strong concerns for the continue barriers in striving to get a home in these measures.

We single-mindedly ask for an amendment to the languages pertaining to the application of federal and its jurisdiction of compact and commerce on Hawaiian Home Lands. There's too much conflicting passage with state's influence in its hope to help the (n) ative Hawaiian with references to departmental regulation.
