PURPOSE: The purpose of S.B. 2807 is to require financial institutions to report instances of suspected financial abuse of an elder directly to the appropriate police department instead of the Department of Human Services (DHS).

DEPARTMENT'S POSITION: DHS strongly supports this Administration-sponsored bill.

DHS does not have the legal authority to directly seek judicial authorization to seize documents, freeze accounts or take other measures to immediately secure financial assets that may be at risk. Additionally, the DHS is without trained staff who have the expertise to review the complex financial records and transactions for the financial abuse cases identified by financial institutions.

Finally, the DHS does not conduct criminal investigations, nor does it prosecute crimes. The appropriate entity to receive reports of suspected financial abuse from financial institutions is the local police department which has investigators and legal

remedies at its disposal to immediately stop access to an elder's financial accounts when warranted.

TESTIMONY ON S.B. 2807 RELATING TO FINANCIAL ABUSE OF ELDERS

TO THE HONORABLE SUZANNE CHUN OAKLAND, CHAIR, AND THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEES:

My name is Iris Ikeda Catalani, Commissioner of Financial Institutions ("Commissioner"). I appreciate the opportunity to provide comments on behalf of the Department of Commerce and Consumer Affairs ("Department") regarding Senate Bill No. 2807.

This measure requires financial institutions to report instances of suspected financial abuse of an elder directly to the appropriate police department instead of the Department of Human Services.

The Department supports the intent of this bill, as we know that financial institutions appreciate the consequences of financial abuse on elders. When this law was first established, the DHS wanted to know which elders may be victims of financial abuse so that they could cross-reference names in their database, thus the reporting of these suspected cases were reported to DHS, then to the appropriate county police departments if the DHS did not have a case on the alleged victim (elder).

For the financial institutions, we would like to have clarification on what type of reporting is required in the telephone call and subsequently for the written report. We believe there will be confusion on the part of financial institution staff if they do not know how to report these suspected incidences of financial abuse to the appropriate police departments. In addition we seek clarification on what the police departments require in the written reports and whether the financial institutions are able to share the type of information sought by the appropriate police departments.

We understand that DHS does not have the power to stop financial abuse of an elder, consequently, they believe the reporting should be given to a more appropriate government agency.
