Quick Community Updates

- **Campbell Industrial Park Street Signage** – I got a complaint from a constituent about the absence of street signage in Campbell Industrial Park. I contacted the Director of the City's Department of Facility Maintenance and got word back that they would be replacing missing street signs at the intersections of Kalaeloa & Malakole and Kalaeloa & Kauhi by mid-December.
- **Kapolei Parkway** – the City informed us that the section of Kapolei Parkway from the edge of D.R. Horton Schuler's Mehana residential development to Kamokila Boulevard will be under construction starting this month and be completed by January 2014. The project was delayed because the contractor, Royal Contracting, had problems getting grading permits from the City.
- **Renee Shoji Named Outstanding Educator** – a big congratulations to Kapolei High School teacher, Renee Shojj, who was named as a 2011-2012 Outstanding Educator by Oceanic Time Warner Cable and Pizza Hut.

H-Power Launches Third Boiler

Several of my colleagues and I congratulated Covanta and City officials with a certificate from the State Legislature at the H-Power facility in Campbell Industrial Park. H-Power recently added a third boiler to its existing waste-to-energy facility, which is managed by Covanta and owned by the City. The expansion added a second turbine-generator which will allow for combustion of a greater variety of waste, including bulky items. The expansion created 300 additional jobs during its construction period and was finished ahead of schedule and under budget. The additional boiler is capable of burning 300,000 tons of refuse per year, so H-Power will now process 900,000 tons of trash per year. H-Power provides power to approximately 65,000 homes and recovers 20,000 tons of metal for recycling each year. The third boiler cost an estimated \$302 million.



Makakilo Resident Nick Young Celebrates 65th Birthday

I surprised Makakilo resident Nick Young with a certificate from the State Senate at his 65th Birthday Party in Ewa Beach on October 13th. It wasn't simply an occasion for him, but rather an opportunity for others to celebrate and express their gratitude to Nick for sharing so much of his life with them. So far, Nick has had a full, rich life. He graduated from the University of Hawai'i with a degree in sociology. He then served our country admirably in the U.S. Navy Reserves, going on active duty for two years. In 1979, he started working as a flight attendant for United Airlines in San Francisco. A new chapter in his life began when he met fellow flight attendant, Julie, who he literally swept off her feet. They were married 8 months later and 32 years later, they still are enjoying each other's company as husband and wife. The second love of his life, after Julie, is making surfboards, which he has been doing since high school. In 1994, he started his own company, "Young Hawaiian Surfboards". Why? Because when he came back from the mainland, surfboards were so expensive, he decided to make his own and go commercial. GMO Labeling Bigger Issue Locally and Nationally

During my 6 years at the Capitol, I've been a strong advocate for GMO labeling and continue to support this cause. Since 2008, I've been introducing legislation to label GMO "whole foods", to label GMO fish, and to set up a farmer notification system so people would know where all the field tests are taking place. I've been disappointed that we haven't been able to get any of these bills passed into law. What I keep coming back to is that this is common sense. We have a right to know what we're eating. The GMO industry should do what the organic industry did on a shoestring budget back in the 1970s—and that is a national campaign promoting organics. I remember 5 years ago suggesting this in an ENE committee meeting to the GMO industry. If they think their product taste better and is better for us, then do a national media campaign and convince us to buy GMOs. I never got a satisfactory answer to this question. So, I'll ask again. Why not, Monsanto? I've been a part of the on-going efforts of **Label It Hawai'i** to bring this issue to more people's attention. You might be aware that the people of California voted on Proposition 37 on November 6th, which would've required the labeling of GMO foods in that state. Unfortunately, that ballot initiative fell short with 47% of the vote, largely due to the nearly \$50 million that was spent by the GMO industry to defeat the measure. The Makakilo-Kapolei-Honokai Hale Neighborhood Board voted to pass a motion in support of labeling of GMO foods at their meeting on October 24th. Hawai'i Energy Policy Forum Celebrates 10th Anniversary

Energy and Environmental Protection Committee Chair, Rep. Denny Coffman and I honored the Hawai'i Energy Policy Forum (HEPF) to celebrate their 10th Anniversary on October 15th. I've been a member of HEPF since 2009, when I was appointed the Chair of the Senate Energy and Environment Committee. HEPF was formed in May 2002 as a project of UH to bring together major stakeholders and community leaders in order to develop an energy strategy and supporting policies through the year 2030. The objective of HEPF is to help our state achieve a sustainable, affordable, safe, and reliable energy system. To establish a baseline starting point, HEPF commissioned studies on environmental, regulatory, economic, social, and cultural issues relating to Hawai'i's energy future. To focus on core outcomes, HEPF adopted a comprehensive 10 Point Action Plan and established Action Plan Working Groups to implement plans for: (1) renewable energy; (2) energy efficiency; (3) regulatory reform; (4) hydrocarbons future; (5) social and cultural impacts; (6) reducing greenhouse gas emissions; and (7) communication and outreach. In support of its recommended policies, HEPF has conducted annual legislative briefings, public briefings, including an annual Hawai'i Clean Energy Day, public outreach through reports, and produced a 2-year television series on "Hawai'i: The State of Clean Energy." I thank them for their efforts in building the foundation for clean and sustainable energy that can be a model to the nation and world.
