As you may know, Hawaii will be host to the Asia Pacific Economic Cooperation (APEC) this month between November 8 through November 13. Hosted by President Obama, the leaders of 21 countries and hundreds of other high level officials will be in Oahu during these dates for the summit. In addition to government officials, there will be more than 20,000 people coming to Hawaii for APEC.

The summit will primarily be centered around Waikiki and Ko Olina. Security will be heighted and many roads will be closed throughout the week of APEC. It would be advisable to stay away from those areas and off the roads if possible.

We are just a short two months from the next legislative session starting in mid-January. Legislation is handled in two-year intervals with the upcoming session being the second year of the process. This means many issues from last session will most likely be seen once again this session.

Drug Nuisance Abatement Program

The goal of drug nuisance abatement is to close down "drug houses" through use of civil lawsuits and civil restraining orders. Working with police, prosecutors and the community, we will use every LEGAL means, including targeting the suspected drug dealers and removing them from the drug houses through use of injunctions, to STOP illegal drug activity.

How Can you Help?

If you suspect someone is dealing drugs in your neighborhood you can call the Honolulu Police Department Narcotics Vice Division at **529-3101** or you may report suspicious activity online at www.honolulupd.org/nv/report.htm.

Information needed to help investigators with your complaint include:

- 1. Location: Exact address (if possible) or description of location
- 2. Suspects: Names—full names, any personal information will help.
- 3. Description: Height, weight, hair color, eye color, complexion, type of clothing worn, ethnic background.
- 4. Vehicles: License plate numbers of any vehicles used by the suspects, description of vehicles.
- 5. Drugs: Type of drug that you believe is being sold or used.
- 6. Date and Time: Note the time that the illegal activity is occurring (try to be accurate. Example: During the morning hours between 9 p.m. to 4 a.m. This helps the investigator).
- 7. Contact Number: Complaints can be made anonymously, but a name and contact number can help the investigator greatly. All information is kept confidential.
- 8. Activity: What type of activity is happening to make you believe that possible drug dealing is occurring.
 - •Vehicle coming and going at all hours
 - •Loud parties all the time
 - •People coming and going frequently
