Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1263, H.D. 2, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO IRRIGATION,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to protect Hawaii's agricultural industry by appropriating two fiscal years of funding to operate and maintain the East Kauai Irrigation System.

Your Committee on Conference has amended this measure by:

- Inserting a one-year appropriation of \$75,000 for improvements to the East Kauai Irrigation System;
- (2) Including a one-year appropriation of \$45,000 for improvements to the Peekauai Ditch Irrigation System, also known as Menehune Ditch, and all appurtenances thereto;

- (3) Changing its effective date to July 1, 2013; and
- (4) Making technical, nonsubstantive amendments for clarity, consistency, and style.
