Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1287, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PERSONAL INFORMATION,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to help ensure that agerestricted goods and services are not purchased by underage individuals by specifying that the machine-readable zone of an individual's Hawaii identification card or driver's license may be scanned to verify, if the business has a reasonable doubt, that the individual has reached the minimum age required to purchase the agerestricted goods or services, rather than to verify that the individual has reached eighteen years of age or older.
