Your Committee on Judiciary, to which was referred H.B. No. 1287 entitled:

"A BILL FOR AN ACT RELATING TO PERSONAL INFORMATION,"

begs leave to report as follows:

The purpose of this measure is to help ensure that agerestricted goods and services are not purchased by underage individuals by repealing the requirement that reasonable doubt as to an individual's age exist to permit a business to scan the machine-readable zone of a Hawaii identification card or driver's license to verify an individual's age.

The Liquor Commission of the City and County of Honolulu; Department of Liquor Control of the County of Hawaii; Seven-Eleven Hawaii, Inc.; Hawaii Food Industry Association; Mothers Against Drunk Driving Hawaii; and Coalition for a Drug-Free Hawaii supported this measure. The Office of Consumer Protection of the Department of Commerce and Consumer Affairs, American Civil Liberties Union of Hawaii, and two concerned individuals opposed this measure.

- Changing its effective date to January 1, 2100, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.
