"A BILL FOR AN ACT RELATING TO PROCUREMENT,"

The purpose of this measure is to reduce unnecessary spending in state government by:

- (1) Allowing the past performance of a bidder to be factored into the selection of a contractor, including a review of delays, cost overruns, corrective actions, and responses to notices of deficiencies; and
- (2) Requiring assessments of prior work in the selection of a contractor.

The Department of Education and The Pacific Resource
Partnership supported this measure. The Department of
Transportation opposed this measure. The State Procurement
Office, Department of Accounting and General Services, General
Contractors Association of Hawaii, Building Industry Association
of Hawaii, and Hawaii Regional Council of Carpenters provided
comments.
