Your Committee on Energy & Environmental Protection, to which was referred H.B. No. 901 entitled:

"A BILL FOR AN ACT RELATING TO SOLID WASTE,"

begs leave to report as follows:

The purpose of this measure is to:

- Clarify that the solid waste management surcharge (1)applies to certain solid waste disposed of in landfills or shipped outside the State for disposal;
- (2)Clarify that the solid waste management surcharge applies to solid waste disposed of at waste-to-energy facilities that accept 150,000 tons or more of solid waste annually;
- (3) Increase the solid waste management surcharge using a tiered structure commensurate with the impact of the means of disposal on the Department of Health; and
- Clarify who is responsible for paying the solid waste (4) management surcharge.

The Department of Health; Department of Environmental Services of the City and County of Honolulu; and Sierra Club, Hawaii Chapter provided testimony in support of this measure.
