The purpose of this measure is to assist the Department of Labor and Industrial Relations' Disability Compensation Division in reducing its hearings backlog, defray costs associated with the Division's automation system, and improve workers' compensationrelated services to the public by:

- Establishing a Disability Compensation Division Special Fund to cover personnel and operating costs incurred in the administration of the State's workers' compensation law;
- (2) Authorizing the Disability Compensation Division to establish reasonable fees for subpoenas and for filing injury reports and hearings applications; and
- (3) Authorizing the establishment of and funding two fulltime positions.

The Department of Labor and Industrial Relations supported this measure. The Chamber of Commerce of Hawaii and Hawaii Insurers Council opposed this measure. The International
