Your Committee on Consumer Protection & Commerce, to which was referred S.B. No. 1075 entitled:

"A BILL FOR AN ACT RELATING TO PHYSICAL THERAPY,"

begs leave to report as follows:

The purpose of this measure is to require physical therapists to obtain continuing competence units in order to renew their licenses to practice.

Testimony in support of this measure was received from the Board of Physical Therapy.

Your Committee finds that minimizing ineffective or potentially harmful techniques in the practice of physical therapy requires an awareness of the current clinical research and methods. Accordingly, requiring licensed physical therapists to accumulate thirty continuing competence units in each license cycle will ensure that these professionals remain current and upto-date in their practice.


