Your Committee on Finance, to which was referred S.B. No. 82,
S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE HAWAII PUBLIC HOUSING
AUTHORITY,"

begs leave to report as follows:

The purpose of this measure is to improve the ability of the
Hawaii Public Housing Authority (HPHA) to serve its tenants by:

- (1) Authorizing HPHA to receive, use, and dispose of
property including, with legislative approval, to sell
real property, in support of HPHA's purposes, powers,
and programs; and
- (2) Authorizing HPHA to receive, subject to certain
conditions, any property for the benefit of residents
assisted by HPHA programs and engage the services of
volunteers.

No testimony was received on this measure.

Your Committee has amended this measure by:

- (1) Requiring that public housing preferences for tenant
selection, other than those required by federal law, be
established by the Legislature; and

- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.
