Your Committees on Agriculture and Economic Development & Business, to which was referred S.B. No. 993, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO AGRICULTURAL LOANS,"

beg leave to report as follows:

The purpose of this measure is to support local farming by expanding the agricultural loan program offered by the Department of Agriculture to include a new loan for farm innovations and expanded eligibility for the new farmer loan.

The Department of Agriculture, Ulupono Initiative, Hawaii Farm Bureau Federation, and one individual testified in support of this measure.

Your Committees have amended this measure by:

- Authorizing the Department to issue a new class of loans for biosecurity projects and making necessary conforming amendments to existing statutes; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.
