Your Committee on Ways and Means, to which was referred
S.C.R. No. 191 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE BOARD OF
EDUCATION, IN CONSULTATION WITH THE STATE LIBRARIAN, TO
EXPLORE THE FEASIBILITY OF ACTIVATING A STATEWIDE LIBRARY
ADVISORY COMMISSION,"

begs leave to report as follows:

The purpose and intent of this measure is to request the
Board of Education, in consultation with the State Librarian, to
explore the feasibility of activating a statewide library advisory
commission.

This measure also requests the Board of Education to report
its findings, recommendations, and proposed legislation, if any,
to the Legislature prior to the convening of the 2014 Regular
Session.

Your Committee finds that a statewide library advisory
commission could increase and diversify usage of library
facilities. Requesting the Board of Education to study and report
on the feasibility of establishing a statewide library advisory
commission would provide the Legislature with information
necessary to determine whether to establish such a commission.

As affirmed by the record of votes of the members of your
Committee on Ways and Means that is attached to this report, your
Committee concurs with the intent and purpose of S.C.R. No. 191
and recommends its adoption.
