exchange between the State and Hawaii Baptist Academy.


Your Committee received testimony in support of this measure
from the Department of Land and Natural Resources, Office of
Hawaiian Affairs, and Hawaii Baptist Academy. Your Committee
received testimony in opposition to this measure from two
individuals.

The land exchange is between the State and Hawaii Baptist
Academy, a nonprofit corporation, which was approved in principle
by the Board of Land and Natural Resources at its meeting on
October 24, 2008, under agenda item D-13, as amended at its
meeting on August 10, 2012, under agenda item D-9.

As affirmed by the record of votes of the members of your
Committee on Water and Land that is attached to this report, your
Committee concurs with the intent and purpose of S.C.R. No. 20 and
recommends that it be referred to the Committee on Ways and Means.




