"SENATE RESOLUTION AUTHORIZING THE ISSUANCE OF A NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS PURSUANT TO SECTION 171-53, HAWAII REVISED STATUTES, RELATING TO RECLAMATION AND DISPOSITION OF SUBMERGED OR RECLAIMED PUBLIC LAND,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the issuance of a non-exclusive easement covering a portion of state submerged lands.

Your Committee received testimony in support of this measure from the Department of Land and Natural Resources.

The subject property is identified as tax map key (1) 6-8-004 seaward of parcel 14. The area of the seawall comprising approximately 101 square feet has encroached on state owned submerged land prior to 1964. The owner of the subject property applied to the Land Division of the Department of Land and Natural Resources to request a grant of a fifty-five year term for a nonexclusive easement for seawall and step purposes. On December 14, 2012, under agenda item D-16, the Board of Land and Natural Resources approved the request for the term easement for seawall and step purposes.
