Your Committee on Ways and Means, to which was referred S.R. No. 77 entitled:

"SENATE RESOLUTION REQUESTING THE EXECUTIVE OFFICE ON AGING TO CONTINUE ITS RESEARCH OF THE TIMEBANKING CONCEPT FOR HAWAII'S RESPITE SYSTEM,"

begs leave to report as follows:

The purpose and intent of this measure is to support the coordination of a statewide system of aging and caregiver support services in the State.

More specifically, this measure requests the Executive Office on Aging to:

- Continue its research on timebanking as a sustainable (1)and alternative currency system that will enhance and strengthen Hawaii's respite system; and
- Submit a report on its findings and recommendations, (2) including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2014.

Your Committee received written comments in support of this measure from the Executive Office on Aging.

Your Committee finds that alternative forms of currency to support increasing community needs for respite care services may improve many identified service gaps. Accordingly, your Committee





finds that timebanking may offer a more sustainable provision of social services and that further research and investigation is needed to determine its viability.

As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee concurs with the intent and purpose of S.R. No. 77 and recommends its adoption.
