<u>HB 1374</u> <u>Status</u>	RELATING TO PROCUREMENT. Allows past performance to be factored into future bid selection of a contractor including a review of delays, cost overruns, and compliance with project requirements.	EDB, FIN
HB 589 Status	RELATING TO THE PUBLIC LAND DEVELOPMENT CORPORATION. Repeals chapter 171C, HRS, relating to PLDC. Repeals requirement that HCDA assist the PLDC in certain specified areas.	EDB, WAL/FIN
