Requires the chief election officer to establish procedures to select a letter of the alphabet by lot and arrange candidate names on ballots in alphabetical order of the last names, beginning with the randomly selected letter. HB 33 Status	RELATING TO PUBLIC ORDER. Makes permanent the prohibition against urinating or defecating in public within the boundaries of downtown Honolulu.	JUD

<u>HB 38</u> <u>Status</u>	RELATING TO UNLAWFUL CHOP SHOP ACTIVITY. Establishes criminal offenses of unlawful chop shop activity in the first and second degrees.	JUD
<u>HB 88</u> <u>Status</u>	RELATING TO CONSTRUCTION OF LAWS. Repeals law providing that the terms "or" and "and" have the meaning of the other or of both.	JUD
<u>HB 129</u> <u>Status</u>	RELATING TO CHILD WITNESS TESTIMONY. Enacts the Uniform Child Witness Testimony by Alternative Methods Act, which authorizes courts to allow for children to testify in a place other than an open forum or away from the finder of fact, court, or parties.	JUD
HB 147 Status	RELATING TO SIMULATED FIREARMS. Includes the use of a simulated firearm in the first-degree offenses of terroristic threatening and robbery.	JUD

DECISION MAKING TO FOLLOW
