RELATING TO FOSTER CARE.

HUS, JUD, FIN

(HSCR975) **Status** 

Establishes the young adult voluntary foster care program to care for and supervise eligible foster youth until age twenty-one. Effective July

1, 2050. (SB1340 HD1)

SB 74, SD1

RELATING TO CORRECTIONS.

PBS, JUD, FIN

(HSCR983) Status

Allows committed persons to create and place for sale approved products and crafts. Allocates proceeds to rehabilitation programs, the crime victim compensation special fund, and the committed person's account. Requires department of public safety to study other states' practices on the making and sale of arts and crafts by inmates.

Requires a report to the 2014 legislature. Effective 07/01/2050. (SD1)

## **DECISION MAKING TO FOLLOW**
