RELATING TO WORKERS' COMPENSATION DRUGS.

LAB/HLT, FIN

Status

Establishes price caps for the Hawaii workers' compensation insurance system for drugs. Authorizes reimbursement of a dispensing fee to physicians who dispense prescription medications directly to patients.

Effective July 1, 2013.

HB 1240

RELATING TO MEDICATIONS.

LAB/HLT, CPC

Status

Restricts reimbursement of repackaged prescription drugs and compound medications to amounts comparable to that of retail

pharmacies under state law.
