SB 890, SD1 (SSCR324) Status

RELATING TO THE HAWAII LABOR RELATIONS BOARD.

LAB

Authorizes the governor to appoint an acting member of the Hawaii labor relations board if a regular member is temporarily recused. Clarifies that an acting member shall be appointed for the case in which the recusal occurred, and that the acting member's appointment shall terminate when the final decision is filed or the case is

withdrawn. (SD1)
