HB 218, HD1 (HSCR39) Status	RELATING TO THE CORRECTIONS POPULATION MANAGEMENT COMMISSION. Adds the OHA administrator and a member of the public who is knowledgeable about issues relating to the criminal justice system and has substantial experience or expertise in traditional Native Hawaiian practices to the corrections population management commission. HB 345 Status	RELATING TO FIRE PROTECTION. Authorizes the county fire chiefs to require that various types of construction comply with the fire code.	PBS, CPC
HB 945 Status	RELATING TO THE HAWAII PAROLING AUTHORITY. Allows designees be appointed to the panel that reviews applicants for the paroling authority and nominates members for the Governor's consideration.	PBS, JUD
HB 947 Status	RELATING TO PUBLIC SAFETY. Clarifies the intent of Act 139, Session Laws of Hawaii 2012, by defining the quorum required to take action on matters before the Hawaii Paroling Authority, amending conditions for time served for a parole violation, and correcting the sunset section. HB 950 Status	RELATING TO COMMITTED PERSONS ON FURLOUGH. Adds child support payments as obligations for inmates on furlough who are employed and delineates percentage of earnings that shall be deducted to satisfy outstanding orders regarding restitution, crime victim compensation, other fees and fines, and child support and	PBS, JUD

reimbursement to the State for the cost of room and board.

HB 1197 Status	RELATING TO VICTIM RESTITUTION. Provides that victim restitution orders shall be enforced notwithstanding any other law or court order to the contrary.	PBS, JUD
HB 1278 Status	RELATING TO COURT FEES. Increases various court service fees of the sheriff, police officers, and serving officers.	PBS, JUD, FIN
HB 1114 Status	RELATING TO ARRESTS. Authorizes Federal Protective Service officers to arrest a person for an offense under the Hawaii Penal Code without a warrant under specified conditions.	PBS, JUD
HB 1279 Status	RELATING TO PUBLIC SAFETY. Appropriates funds for state programs related to the re-integration of offenders into the general population.	PBS, FIN
