conservation district.

SB 382, SD1 (SSCR823) RELATING TO FUEL TAX REVENUES.

TRN, FIN

(SSCR823) Status

Permits the county of Hawaii to appropriate the county's share of fuel tax revenues for the maintenance of substandard private subdivision roads that are used by the public. Provides that neither the State nor the county shall be required to install infrastructure improvements if the roads are thereafter sold to a private entity. Effective 07/01/50.

Proposed HD1: Authorizes ordinances permitting county use of wheel boots for parking violations. Establishes that unless authorized by a county, no person, other than the registered owner of a motor

vehicle, may apply a wheel boot to a motor vehicle.
