HB 1249 Status RELATING TO THE HAWAII COMMUNITY DEVELOPMENT

DISTRICT.

Establishes a new community development district located in the Banyan Drive area in Hawaii county and places it under the jurisdiction of the Banyan Drive community development board. Establishes the Banyan Drive community development board. Requires the department of land and natural resources to deed over all leases it holds within the new district to the Hawaii community development authority. Amends the composition, selection, and replacement of the members of the Hawaii community development

authority. Makes an appropriation to the Hawaii community development authority to carry out the purposes of this Act.

HB 550 Status RELATING TO PUBLIC LAND LIABILITY.

Amends and clarifies the definition of "improved public lands" in Act

82, Session Laws of Hawaii 2003, for purposes of limiting liability for public entities based on the duty to warn of dangers on public lands.

HB 583 Status RELATING TO GOVERNMENT.

Requires the department of land and natural resources to establish an

inventory of public facilities on the lands of the public land trust to which state agencies hold title. Requires state agencies to provide the department with an inventory of buildings and facilities by January 1, 2014, and to provide the department with an updated report annually.
