provided reasonable safeguards are in place.

RELATING TO PROCEEDINGS BEFORE THE LABOR AND **HB 921** JDL, WAM

INDUSTRIAL RELATIONS APPEALS BOARD. (SSCR961)

Affirms the authority of the Labor and Industrial Relations Status & Appeals Board to issue orders or take other appropriate action Testimony to enforce its rules and orders and allows parties to

electronically file appeals to the appellate court.

RELATING TO COLLECTIVE BARGAINING. JDL, WAM HB 924, HD1, SD1

Requires the Hawaii labor relations board to provide written (SSCR963) notice of a hearing to all parties by first class mail at least fifteen days before the scheduled hearing. Makes housekeeping Status & amendments to the law relating to the scope of negotiations **Testimony**

> between the public employer and the exclusive representative to conform to existing law. Effective 07/01/50. (SD1)

RELATING TO THE EMPLOYMENT SECURITY APPEALS **HB 925** JDL, WAM

REFEREE'S OFFICE. (SSCR960)

Modifies the notice period for unemployment appeal hearings from fifteen days to twelve days and authorizes notices and Status &

correspondence to be sent electronically in lieu of notice by mail. Testimony

HB 927 RELATING TO THE EMPLOYMENT AND TRAINING FUND. JDL, WAM Strengthens the use of the Employment and Training Fund to (SSCR954) assist local small businesses through training programs identified in the State's economic development strategy as Status & **Testimony** identified by the Department of Business, Economic Development, and Tourism and local Workforce Investment Boards. HB 1412, SD1 RELATING TO SMALL BOAT HARBORS. WTL/THA, WAM Requires DLNR to accommodate mooring of native Hawaiian (SSCR945) canoes owned by nonprofit entities and used for educational purposes in small boat harbors. (SD1) Status & Testimony
