WTL, JDL Ensures public lateral access along the shoreline by extending (HSCR758) for two years the requirement that landowners remove humaninduced, enhanced, or unmaintained vegetation interfering with Status & such access and also extending DLNR's enforcement duty to <u>Testimony</u> maintain such access. Effective June 29, 2013. (HB17 HD1) HB 414, HD2 RELATING TO WAIPIO VALLEY. WTL, WAM Establishes the Waipio Valley Advisory Commission to advise (HSCR890) the Department of Land and Natural Resources on the development of a long-term plan for ensuring the proper Status & stewardship, preservation, and maintenance of Waipio Valley. Testimony Appropriates funds for the design and construction of flood damage reduction and stream stabilization in Waipio Valley. Effective July 1, 2020. WTL, WAM Requires the Chairperson of the Board of Land and Natural (HSCR677) Resources to convene a Mala Wharf Task Force to examine the feasibility of redeveloping the collapsed pier at Mala Wharf on Status & the island of Maui. Effective July 1, 2020. (HB1423 HD1) **Testimony HB 1424** RELATING TO THE ACQUISITION OF RESOURCE VALUE WTL, WAM LANDS. (HSCR663) Requires DLNR, in consultation with the Hawaiian Islands Land Trust and notwithstanding board approval, to engage in efforts Status & to acquire the parcel of land located at Lipoa Point, identified as **Testimony** 

TMK 2-4-1-001-010-0000. Makes an appropriation.



<u>HB 1133</u> (HSCR412) RELATING TO PUBLIC LAND.

Repeals the Public Land Development Corporation. Transfers certain assets to the Department of Land and Natural Resources.
