<u>HB669</u>	RELATING TO OCEAN RECREATION. Amends the definition of "thrill craft". Limits number of vessels that parasail and thrill craft permit holders are allowed to operate per permit.	OMH, CPC
<u>HB670</u>	RELATING TO CHECK CASHING. Prohibits persons from engaging in the business of check cashing without a registration issued by the commissioner of financial institutions.	CPC, FIN

<u>HB672</u> RELATING TO HEALTH.

HLT, CPC

Requires cigarettes and tobacco products to be stored for sale behind a counter. Requires advertisements that promote or encourage the purchase or use of cigarettes or tobacco products to be placed twenty-five feet away from children's products, toys, cookies, candy, ice cream, gum, or snacks. Requires advertisements that promote or encourage the purchase or use of cigarettes or tobacco products to be placed four feet off the floor. Permits exceptions for retail tobacco stores, bars, or establishments where the minimum age for admission is eighteen. Includes electronic cigarettes under the definition of tobacco products.

HB673 RELATING TO PESTICIDES.

AGR, HLT, FIN

Requires the Department of Agriculture (DOA) to establish and implement a pesticide use reporting system in the State, including investigations of health complaints by the Department of Health. Requires users of pesticides to report usage to DOA. Permits DOA to impose a fee to recover costs.

HB674 RELATING TO EDUCATION.

EDN, FIN

Requires charter schools to complete an annual independent financial audit. Requires the state public charter school commission (commission) to develop procedures for conducting criminal history checks of persons who are employed or seeking employment in any position that places them in close proximity to children. Specifies enrollment requirements. Specifies when an employer or potential employer may use criminal history information to terminate or deny employment. Requires commission members to disclose to the commission a list of all charter schools in which the member is an employee, governing board member, vendor, contractor, agent, or representative and disqualifies members from voting on or participating in the discussion of such matters. Authorizes the commission to hire employees without regard to chapters 76 and 89, HRS. Removes the requirement that a nonprofit organization that governs a conversion charter school make minimum annual contributions to the charter school. Makes other amendments to chapter 302D, HRS, for purposes of clarity and consistency.

HB675 RELATING TO EDUCATION.

Promotes awareness of the definition and characteristics of dyslexia and other similar learning disorders. Requires DOE to provide professional development to teachers relating to students with dyslexia. Requires the Hawaii teachers standards board to establish licensure standards for reading specialists.

HB694 RELATING TO TAXATION.

FIN

Repeals the temporary increase in income tax rates established by Act 60, SLH 2009, one year ahead of schedule by changing the sunset date of the increased tax rates from 12/31/2015 to 12/31/2014.

<u>HB695</u> RELATING TO ELECTRICIANS AND CONTRACTORS.

CPC

Exempts out-of-state electricians performing high-voltage electrical work for a public utility from licensing laws for electricians and from quotas governing contractors on construction sites who employ individuals performing electrical work.

HB696 RELATING TO THE OFFICE OF THE LIEUTENANT

FIN

GOVERNOR.

Permits a lieutenant governor whose legal residence is on an island other than Oahu who is required to remain away from the island of the lieutenant governor's legal residence but within the State overnight or longer while on official business to receive an allowance to cover personal expenses such as transportation, board, lodging, and incidental expenses, that is to be separate from the lieutenant governor's salary.

HB697 MAKING APPROPRIATIONS FOR PUBLIC EMPLOYMENT FIN

COST ITEMS.

Makes appropriation for the public employment cost items of and cost adjustments for employees of legislative agencies.

HB698 RELATING TO TAXATION. FIN

Amends the motion picture, digital media, and film production income tax credit by (1) adding additional work and infrastructure incentive credits; (2) establishing a qualified persons crew training and advancement program rebate; (3) requiring the payment of a fee to apply for the tax credit; (4) increasing the cap amount of the tax credit; and (5) requiring that a waiver be granted to include the wages of nonresident crew in qualified production costs. Sunset 01/01/2018.
