The Senate of the Twenty-Seventh Legislature of the State of Hawai'i, Regular Session of 2013, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that she had read and approved the Journal of the Twenty-Third Day.

At this time, Senator Chun Oakland introduced Mr. Robert Scott Wall, nominee to the State Rehabilitation Council who was seated in the gallery.

Senator Espero honored the valiant Tuskegee Airmen, who overcame segregation and racial prejudice to become one of the most highly respected fighter groups of World War II, and extended deepest gratitude for the sacrifices made and the honor the airmen have brought to our nation.
