THIRTY-FIRST DAY

Thursday, March 14, 2013

The Senate of the Twenty-Seventh Legislature of the State of Hawai'i, Regular Session of 2013, convened at 11:33 a.m. with the Vice President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Kim who was excused.

The Vice President announced that he had read and approved the Journal of the Thirtieth Day.

At this time, Senator Green noted that it was the State Council on Developmental Disabilities' 13th Annual Day at the Capitol, and welcomed guests from Hilopa'a Family to Family Health Information Center, Ho'opa'a Hawai'i Autism State Implementation Grant, and the Hawaii Waiver Providers Association; Executive Administrator Waynette Cabral; and the participants, family members, personal assistants, service providers, and other advocates for developmental disabilities from across the state who were seated in the gallery.

Senator Slom rose to recognize and congratulate the recipients of the United States Small Business Administration's 2013 State of Hawai'i Awards, and noted that the annual awards honor and recognize outstanding leaders in Hawai'i's small business community who have demonstrated outstanding skills, savvy, staying power, and the ability to create success; created jobs; have shown innovation in both products and services that have increased revenues annually; and have advocated for small businesses.

Senator Thielen recognized Dr. James Kwong and David Yogi, who was not in attendance, of Yogi Kwong Engineers, LLC for being named Small Business Person of the Year. Dr. Kwong was accompanied by Mel Racadio of Bank of Hawaii who nominated them for the award.

Senator Kahele congratulated Alan Ikawa, president, chief executive officer, and founder of Big Island Candies, for being named the Entrepreneurial Success of the Year. Mr. Ikawa was accompanied by Art Taniguchi and Roberta Chu of Bank of Hawaii who nominated him for the award.

Senator Slom recognized FSC Architects for being named Small Business Exporter of the Year, and introduced co-founders Jim Freeman, Ralph Shelbourne, and Ben Candari, who were not in attendance but who were represented by Sandra Vajcs, Rowena Tomas, Dori Gusman, and Dave Ebaugh, as well as Angie Shiroma of First Hawaiian Bank who nominated them for the award.

Senator Tokuda congratulated HanaPa'a Fishing Company, for being named the Family Owned Small Business of the Year, and recognized Sterling Kaya, second-generation owner and operator who was not in attendance.

Senator Ihara recognized Billy Giang, president of Pho Factory and Saigon Garden, for being named Young Entrepreneur of the Year.

Senator Dela Cruz congratulated José Villa, president of Latin Business Hawaii, for being named the Minority Champion of the Year.

Senator Gabbard recognized Naomi Hazelton-Giambrone, co-owner of Element Media, for being named the Women in Business Champion of the Year. Ms. Hazelton-Giambrone was not in attendance; Senator Gabbard introduced Krista Sherkey of Streamline6 Communications who nominated her for the award.

Senator Keith-Agaran congratulated Robert Kawahara, owner of Kawahara + Co., Certified Public Acountants, LLC, for being named the Financial Services Champion of the Year. Mr. Kawahara was not in attendance, but was represented by Art Taniguchi.

Senator Keith-Agaran also recognized Leslie Wilkins, vice president of the Maui Economic Development Board, for being named the Veteran Small Business Champion of the Year. Ms. Wilkins was accompanied by Alvin Imada of Central Pacific Bank who nominated her for the award.

Senator Keith-Agaran then congratulated Craig Swift, director of Maui Economic Opportunity Business Development Division, for being named the Home-Based Business Champion of the Year. Mr. Swift was not in attendance, but was represented by Angie Shiroma.

Senator Slom also introduced Jane Sawyer, Hawai'i district director for the U.S. Small Business Administration.

Senator Galuteria extended an additional welcome to the participants in the State Council on Developmental Disabilities' Day at the Capitol, and introduced his son Sean who represented his peers in the gallery.

At this time, Senator Taniguchi introduced Raynard Soon, newly confirmed member of the Board of Directors of the Research Corporation of the University of Hawai'i.

Senator Green noted that it was World Kidney Day and invited the members to learn more about kidney disease and what could be done to help constituents, friends, and family members across the state to deal with this illness.

Senator Shimabukuro rose to wish Senator Hee a happy 60th birthday.

Senator Slom rose to speak on a point of personal privilege as follows:

"Mr. President and colleagues, this is the 31st day of the session; we've now passed the halfway point. And apparently, some of my colleagues did not know that one of the bills that we worked on and we fast-tracked a week and a half ago was the bill to give relief to small businesses in terms of their unemployment compensation taxes. This is an appropriate time to talk about this today when we honored small business champions. We passed the bill, and I remember at the time that the good chairs of Judiciary and Ways and Means both brought up the fact that the House was trying to cobble the minimum wage bill on top of this one – pass them together – and they both pointed out eloquently that these are two separate issues and that there was a deadline of March 8 to fast-track this. The governor was ready to sign the bill so that there would be

Schedule F, meaning the same unemployment compensation tax rates this year as last year.

"Well, the House did it, that dysfunctional body over there; they continued their belief that they had to put minimum wage on it, and my knowledge is that the bill has died. I don't know if the Department of Labor can extend the deadline; probably not. And what that means is that every business, and particularly the small businesses in our state, will suffer yet another increase this year on unemployment comp.

"But I salute my colleagues: we did the right thing, and we fast-tracked that, but I wanted everybody to know that. Thank you, Mr. President."
