The Senate of the Twenty-Seventh Legislature of the State of Hawai'i, Regular Session of 2013, convened at 11:47 a.m. with the President in the Chair

The Roll was called showing all Senators present with the exception of Senators Green and Solomon who were excused.

The President announced that she had read and approved the Journal of the Forty-Fourth Day.
