The Senate of the Twenty-Seventh Legislature of the State of Hawai'i, Regular Session of 2013, convened at 11:34 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Keith-Agaran and Shimabukuro who were excused.

The President announced that she had read and approved the Journal of the Forty-Seventh Day.

At this time, Senator Hee introduced 27 students from Kahuku High School and their teacher Ms. Uila Vendiola. The students – some of whom would be representing Hawai'i as part of the We the People team in Washington, D.C., and some of whom were members of The Green Club – were visiting the State Capitol to learn firsthand how the legislative process works.

"While recognizing the resolutions' intent to protect against potential adverse impacts to the environment from hydraulic fracturing operations generally associated with the oil and gas industry, and also recognizing the aim of the resolution to protect our State's natural resources and water supplies, hydraulic fracturing has been utilized on a very limited basis in the geothermal industry and, the Department of Land and Natural Resources is unaware of any proposed plans or assessment of potential sites for use of such techniques in Hawaii"

The motion was put by the Chair and carried, the joint report of the majority of the Committees was adopted and S.R. No. 86, S.D. 1, entitled: "SENATE RESOLUTION EXPRESSING CONCERN ABOUT THE USE OF HYDRAULIC FRACTURING IN HAWAII," was adopted with Senator Solomon voting "No."
