Chairperson Senator Nishihara and Members of the Committee:

Thank you for this opportunity to provide testimony on Governor's Message No. 503, submitting for consideration and confirmation as a member on the Advisory Committee on Pesticides, JAMES ESCHLE, Ph. D. The Department would like to express its strong support for Dr. Eschle's nomination.

Dr. Eschle is a professional Entomologist with 13 years of applied research and project management experience with the U. S. Department of Agriculture in a widely diverse research program that focused on the biology and control of insects affecting livestock. Dr. Eschle would serve as the representative from the Structural Pest Control Industry.

Dr. Eschle has served as a consultant/technician to over forty five condominium projects in Hawaii, evaluating problems caused by ground termites and has provided specific recommendations for treatment. His background also includes work conducting environmental assessments of Trifly eradication and evaluating the efficacy of insecticide impregnated ear tags in field trials on pastured cattle in Hawaii.

Dr. Eschle has served as an expert witness on litigation cases involving termite inspections and damage, has conducted several hundred inspections per year for Realtors, and provided classes to pest control operators on behalf of the Hawaii Pest Control Association.

Dr. Eschle's analytical mindset, ability to process critical information and dedication of purpose with matters dealing with pesticides will serve as a vital resource to the Advisory Committee on Pesticides.
