My name is Stephanie Whalen. I am Executive Director of the Hawaii Agriculture Research Center (HARC). I am testifying today on behalf of the center and our research and support staff.

#### HARC strongly supports GM 505.

Early in Dr. McHugh's career he was employed by the Hawaiian Sugar Planters' Association, our organization's former name. He did excellent work for the organization. This was during the period when Oahu-Sugar Company-announced-its-closure. John-was-sensitive-to-the-concern-of-the outer island producers regarding replacing their markets by farms developing on Oahu's former sugarcane lands, and so researched the existing imported crop data. He then set up demonstration plots, had field days and was instrumental in determining that crops such as asparagus, which was 100% imported at that time, grew well here. Locally grown asparagus is now displacing a portion of its imported volume. This crop was also chosen as it used little or no pesticides for its maintenance.

Throughout his experience in agriculture whether consulting for producers or as an employee of an agricultural business Dr. McHugh has demonstrated his conscientiousness for the environment and for viable practices.

The experience and personal attributes of Dr. McHugh will be of great value to the Advisory Committee on Pesticides. 1 urge you to approve his nomination by voting to support GM 505.
