I am deeply honored to have been asked to serve on the Hawaii State Council on Mental Health and humbly ask this Committee to confirm my appointment.

I believe strongly in the value — and neccesity — of a robust mental health network system of care, and see the mission of the council as seeking to continously improve access to quality mental health services in the islands. To that end, since being appointed in an interim capacity to the council in September 2012, I have been assisting the body in conducting a comprehensive needs assessment of adult mental health services in the islands to better understand gaps in programming and to move us closer to implementing an integrated mental health service plan.

In my professional capacity, I bring experience in evidence-based psychotherapy, system of care quality assurance and supervisory work to the council. Currently, I serve as a forensic clinical psychologist at the Hawaii Youth Correctional Facility, where I provide crisis counseling, substance abuse counseling, risk assessments, psychological testing and individual and family therapy.

Before accepting a position at HYCF, I was performance manager for the Hawaii Department of Health's Child and Adolescent Mental Health Division, where I oversaw program monitoring and quality assurance personnel working to develop and maintain accountability systems for a statewide network that provides mental health services to thousands of high-risk children in Hawaii. I have also delivered intensive outpatient services at an eating disorder program in Honolulu, and have served in a Hawaii rural community mental health center and a community-based residential setting, providing individual, family and group therapy to children, adolescents and adults.
