The Maui County Veterans Council respectfully requests that you do **NOT** confirm Chelsea Fernandez in the position of representative to OVS.

This has nothing to do with the person of Ms. Fernandez.

Our problem is that she is too young and has too many personal responsibilities to carry out her mission. Her primary function as a mother and a businessperson has not allowed her to fulfill her function with the Maui CountyVeterans Council.

She has attended **NO** meetings of the Council since her interim appointment, and has made **NO** effort to determine the needs and desires of the Council. She has made it clear that she has **no** intention of meeting with the Council on it's regular meeting dates.

We do understand, thru another source, that she has been in regular communication with the OVS thru it's teleconferencing but has passed **NO** information of ANY sort back to the Council.

Accordingly we have had **NO** representation with the OVS except with Ms. Jackson who does attend our meetings regularly.

Ms. Fernandez was recommended by Col. LLoyd Sodetani. our former representative, who announced that the OVS **demand** was for a young female. He did not consult the Council about what we wanted in any way.

What the Council desires is an older, perhaps retired person, who can actually make our meetings and who cares enough to be in contact with our Council. We would be more than happy to send you a list of 1/2 dozen nominees for selection.

In the alternative, we request that you appoint **no one** to the position as we do not want you to believe that we have representation when, in fact, we do not.

She has offered her services to help stand-down events on Maui and Oahu. Stand Down is a military term. It's a safe position off of the combat zone where weary soldiers retreat to rest, reboot and re-energize. One such event, Women of Power Stand Down, was held on July 12, 2012. About a hundred women veterans attended. The event focused on practical life-skills to help women veterans thrive in a new career out of uniform.

Women veterans returning home from war are at high risk for combat related injuries, unemployment and homelessness. theStrategist[™], a private firm that specializes in designing healthcare transformations that save lives and money, organized and led the event. The U.S. Department of Labor funded part of the event.

Women comprise 15% of all troops deployed to Iraq and Afghanistan. **Hawai'i has one of the highest rates of women veterans in the country**. Post 9/11 women veterans are twice more likely to be unemployed than women who have not served in the military. At the Women of Power Stand Down, women veterans shared their experiences, struggles and triumphs in transitioning from a military career to life after combat. Chelsea played a major role in this event. She will be a strong asset to the Advisory Board on Veterans Services.
