Aloha Chairman Espero, Vice Chair Baker, and Members:

I would like to thank you all for your consideration of my nomination to the Hawai'i Paroling Authority. Further, I would like to thank Governor Neil Abercrombie for his confidence in me as demonstrated by his nomination. Finally, I would like to thank all of my friends and colleagues who have made the time from their busy schedules, to provide testimony in support of my nomination. Your support is truly heartwarming and humbling, and hopefully, someday, earned.

You all have a copy of my resume and so I will not bore you by reading it to you. I hope that you will consider the experience I bring to this nomination. I was part of the first group of women who were able to serve as Police Officers, rather than Police women, in the Honolulu Police Department. I served in HPD's Parole Division from 1975 until 1980 as a beat cop in Kalihi, Kaka'ako and Kahala. As a beat cop, I handled every type of case imaginable....from burglary to homicide, to sex assault to DUI....I have been punched, kicked, beaten, almost killed twice. I was later transferred to the Community Relations Division of HPD and developed the Rape Prevention Program and spoke to over 30,000 people about rape prevention and self-defense.

I left HPD in 1982 to serve as Governor Ariyoshi's State Coordinator of the Office of Affirmative Action, where I implemented Civil Rights laws and the program of Affirmative Action for the State's Executive Departments and the University of Hawai'i and the Department of Education.

I later went on to become the Deputy Administration for the Office of Hawaiian Affairs under Mr. Kamaki Kanahele, where I coordinated the five programs for OHA.

In 1988 I was elected to the House of Representatives for the Makakilo, Ewa, Village Park district and served as Vice Chair of Housing and the Judiciary Committees and later as the Majority Floor Leader.

I later went on to start my on business as a Facilitator and conducted public hearings on some of the most controversial public discussions such as the landfill in Nanakuli, the telescopes on Mauna Kea and Haleakala, and the arrival of the Stryker force in Hawai'i, just to name a few.

I have volunteered countless hours of advocacy for women's rights, victim's rights, and the rights of minorities and Native peoples.

It is, in the context of all of these experiences, that I offer myself for your consideration to serve on the Paroling Board.

It is my hope that you believe that I am qualified for this position and I stand ready to answer any questions that you may have of me. Mahalo for your consideration.

Aloha Senator,

Mahalo for convening your committee for consideration and confirmation of various nominations and my nomination by the Governor to the Hawai'i Paroling Authority. I am submitting this letter in response to your request for additional information.

Ques. 1. Why do you wish to be a member of HPA? I applied for the nomination to the Parole Board because I believe that I can provide a different perspective to the deliberations of the Parole Board. Not only do a bring a background of victim advocacy and legislative experience, but also an understanding of the plight of Native Hawaiians, the majority of whom make up the prison population. I understand that the immediate work before the board is the consideration of parole, the establishment of minimum sentences, deliberations over parole violations and various other requests relating to parole. However, I would like to assist in creating a "big picture" perspective to the work and skills of the board members. We need to assure public safety in our deliberations of parole and part of that public safety concern should also look beyond the time of parole or probation and to the time when convicts re-enter society as full, contributing members. I have worked in the past to establish unique public/private partnerships to resolve shortfalls....and would like to use some of those experiences to enhance the support of our convicts to ensure their future success in our community.

Ques. 2. Given your understanding of the role and responsibilities of HPA, why are you qualified for position? With respect to question two regarding my skills, expertise, and/or knowledge...it is evident that I have had a varied career in relation to criminal justice....from enforcement and development of laws to the selection of judiciary. Diverse background and skills aside, I believe that my innate understanding of the Hawaiian culture and Hawaiian family systems provides an additional element that will be valuable to the Paroling Authority. The disproportionate numbers of Native Hawaiians that come before us trust that I understand and will be fair-minded in my deliberations. It is a small but positive angle that sometimes can make a difference in the attitude and acceptance of decisions by the prisoners that come before us.

Ques. 3. What do you hope to accomplish? What I hope to accomplish in my term of service on the Paroling Authority is the same kind of energy and focus that I always bring to bear on my work. I hope to provide thoughtful, well-informed advice and counsel to the deliberations and

decisions of the Authority. I will try at all times to assist in identify problems that can be addressed by the Department of Public Safety in a meaningful manner. Finally, I will do my best, as I assist in these deliberations, to do no harm to the safety of the people of Hawaii, but work toward the enrichment of our fragile community.

Ques. 4 Can you foresee any possible conflicts of interest? I am not aware of any obvious conflicts of interest in the work I do as a Board member. However, if I find myself in a position of a conflict of interest...either because of knowledge of a victim or relationship or knowledge of a prisoner or a connection to anyone in the specific cases before us, I will remove myself from deliberations sufficiently in advance to neither impede, nor inhibit full and timely deliberations by the board.

I appreciate the time you have taken to read through this response to your questions and remain available to you, the members of your committee, and all Senators voting on this nomination, to answer any additional questions that you may have of me.

Chair Espero, Vice Chair Baker and Members of the Committee:

The Department of Public Safety **supports** Governor's Message 583 nominating Ms. Annelle Amaral as a part-time member of the Hawaii Paroling Authority. Section 353-61, Hawaii Revised Statutes, describes the desired attributes of members of the parole board as follows:

Nominees to the authority shall be selected on the basis of their qualifications to make decisions that will be compatible with the welfare of the community and of individual offenders, including their background and ability for appraisal of offenders and the circumstances under which offenses were committed.

Ms. Amaral's professional experience and active participation in community affairs clearly qualify her for this important position.

Ms. Amaral began her career as a Honolulu police officer and within six years was honored nationally as Officer of the Year by the International Association of Women Police Officers. This award was bestowed upon her for

the exceptional Rape Prevention Program she developed during a time when victims of sexual assault were often perceived by law enforcement as less than credible. She continued to advocate for crime victims in her roles as Coordinator of the Coalition Against Sexual Assault and Domestic Violence Coordinator for the Legal Aid Society of Hawai'i. Governor George Ariyoshi appointed Ms. Amaral to establish the Affirmative Action Office on a state-wide basis, placing her in a position to again advocate for women, this time in employment.

During her lifetime, Ms. Amaral has risen to become a respected leader in the Native Hawaiian community, demonstrating her strong commitment to and advocacy for the first citizens of Hawai'i. Caring deeply about the future of Hawai'i and its people, Ms. Amaral has contributed to advancing Native Hawaiian issues as both a professional and a community volunteer. She serves as the US Army's Native Hawaiian Liaison and is the First Vice President of the Association of Hawaiian Civic Clubs (Oahu Council). A review of her facilitation experience includes many instances where Ms. Amaral is leading the community discussion on controversial subject matters that are of great importance to the Native Hawaiian community, such as the siting of telescopes on Mauna Kea or Haleakala, the introduction of the Superferry and the potential location of wind farms in West Oahu. This type of work is not for the timid.

As many on this Committee will remember, for eight years Ms. Amaral represented the 47th District (Central Oahu, now District 42) in the Hawaii State Legislature. During her time in the House of Representatives, she served as Vice Chair of both the Housing and Judiciary Committees, eventually being appointed as Majority Floor Leader.

We urge your favorable consideration of this nominee. The breadth of experience and commitment to the community exhibited by Ms. Amaral make her a qualified candidate for appointment to the Hawaii Paroling Authority.

Kuhio recognized the need for Native Hawaiians to become more involved in the passage of the Hawaiian Homes Act then before the Congress, and to further become engaged in the intricacies of federal and local government. A Hawaiian civic club was his answer.

We stand firmly behind Annelle Amaral who has been a leader in the civic club movement for a number of years and currently serves as First Vice President of the Association leading several strategic committees.

Always an advocate for social justice, Annelle is well known here in the State Capitol where she served in the House of Representatives as Majority Floor Leader and was named as an Outstanding Legislator. Before that she served on the fourth floor as the Hawaii State Affirmative Action Officer under the administration of Governor George Ariyoshi. Prior to State service, Annelle was one among the first five women to become fully vested Honolulu Police Officers after a lawsuit for equal opportunity was filed in Federal Court. Signed by a number of significant Hawaiian organizations and Army Commanders, the Covenant serves as a commitment of goodwill and cooperation among the signatories.

Annelle has also been a contributing member of the State Judicial Selection Commission appointed by former Senate President Shan Tsutsui, and recently resigned to accept the Paroling Authority appointment.

In a variety of ways Annelle Amaral's skill and commitment have proven her value to the community and State of Hawaii as a dedicated public servant. She is exceptionally well qualified to serve on the Hawaii Paroling Authority and we urge you to approve her appointment.
