Re: Nomination to the Koke'e State Park Advisory Council

In response to your letter of February 20, 2013, I am providing you with the requested information:

- I wish to be a member of the Koke'e State Park Advisory Council so that I would be able to assist in the protection and perpetuation of the values of the Koke'e area while providing for appropriate public usage.
- (2) I perceive the role of a member of the Koke'e State Park Advisory Council as being advisory and providing assistance while the responsibilities include reviewing and assisting in updating and revising the Koke'e state park master plan; advising and assisting in the management of the Koke'e recreational cabin leases; enhancing community education and cultural awareness of Koke'e state park; participating in the protection and preservation of Koke'e state park's natural and cultural resources; and advising and assisting in the overall implementation of the overall implementation of the Koke'e state park master plan.
- (3) I believe that I am qualified for the position based on the knowledge and experience I have gained from my being born and raised in West Kaua'i; being an outdoors person who frequents the Koke'e area; having earned a bachelor of science degree in outdoor recreation; and having been employed for 34 years with the Department of Land and Natural Resources as a park planner and the Kaua'i parks district superintendent. As such, I am very familiar with the natural, cultural, historical, and outdoor recreation resources of the Koke'e area; its stakeholders, usage, opportunities, and management and planning issues; and the park management and park master planning of the area.
- (4) What I hope to accomplish during my term of service, if confirmed, is to improve on the management of Koke'e and Waimea Canyon State Parks through significant increases in the funding, staffing, and public-private partnerships for these two stellar state parks.

- (5) Three qualities that best describe me and that would make me stand out are my knowledge of the Koke'e area, my experience in park planning and park management, and my love of the outdoors. These qualities would benefit the Koke'e State Park Advisory Council with my in-depth knowledge of the Koke'e area, the workings of the Department of Land and Natural Resources, and my passion for the protection of this special place,
- (6) One previous experience that would make me stand out is my 34-year employment with the Department of Land and Natural Resource as a park planner and the Kaua'i parks district superintendent. He attended every Hui o Laka Board of Trustees meeting (on his days off) during that period and dropped by our offices when he was working in Waimea Canyon and Kōke'e State Parks. We developed Hui o Laka's ongoing volunteer stewardship program, Kōkua ia Kōke'e, with his input and guidance. Because he helped us refine the program, Kōkua ia Kōke'e continues to grow in support of the Division's mandate to malama these precious parks.

I strongly support Wayne H. Souza's nomination to the Kōke'e State Park Advisory Council as established by Act 223 of the 2008 Hawai'i State Legislature. Comments: I am concerned about the possibility of Wayne Souza being appointed to the Kokee Advisory Council. During his time as State Parks Superintendent I found him to be obstructionist when it came to volunteer efforts in Na Pali Coast State Park and heard many stories of other people who found him difficult to work with. He seemed to need to control and micro manage to the point where it seemed that little got done as a result. I heard stories of what sounded like pettiness from people trying to deal with him and certainly people were discouraged by his attitude. It is my understanding that these difficulties were part of the reason he was moved out of the position of State Parks Superintendent. This seems important to investigate before pursuing his nomination further. I imagine that Mr. Souza does care about Kokee, but I am concerned that his style will be a liability on the advisory council.
