Chair Hee and Members of the Committee:

The Attorney General strongly supports the reappointment of Lani Ewart to the Commission to Promote Uniform Legislation of the Department of the Attorney General.

Members of the state Commission to Promote Uniform Legislation are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws. Lani Ewart is an attorney at law who has steadfastly and with distinction served on the Commission to Promote Uniform Legislation continuously since 1977. She currently serves as the Chair of the Commission and has regularly attended and actively participated in the meetings of the Commission.

The National Conference of Commissioners on Uniform State Laws requires that each appointed commissioner be a lawyer licensed to practice law and that each commissioner personally attend and participate in the annual meeting of the National Conference. Commissioner Ewart has regularly attended and participated in the annual meetings, even when the amount of appropriated moneys available was insufficient to reimburse her fully for her travel expenses. In recognition of her dedicated service to the promotion of uniform laws, Commissioner Ewart was elected in 1998 to Life Membership in the National Conference. To become a Life Member, a commissioner must serve the National Conference in the voluntary drafting and review of uniform laws for at least twenty years, must be recommended by the National Conference's Executive Committee, and must be elected by an affirmative vote of twoTestimony of the Department of the Attorney General Twenty-Seventh Legislature, 2013 Page 2 of 2

thirds of the commissioners present and voting at the session at which the recommendation is made. Lani Ewart was the first woman commissioner to be elected to Life Membership in the then 106-year history of the National Conference.

During her most recent term that began on July 1, 2010, she served as a member of the Executive Committee, the governing body of the National Conference, as a member of the Drafting Committee on Uniform Statutory Trust Entity Act, of the Drafting Committee on Partition of Tenancy-in-Common Real Property Act (which was renamed to the Partition of Heirs Property Act), of the Standby Committee on Partition of Heirs Property Act, and of the Standby Committee on Uniform Statutory Trust Entity Act, and as a liaison member to the Uniform Law Foundation Trustees. She attended committee meetings as scheduled and each annual meeting of the National Conference held on the mainland during her present term of office.

In view of her demonstrated commitment to the promotion of uniform legislation and her continuing and significant participation in the activities of the National Conference and of the Commission to Promote Uniform Legislation, the continued service of Lani Ewart as a member of the Commission and the National Conference will be greatly beneficial to the State of Hawaii and the National Conference. Consequently, the Attorney General respectfully requests that this Committee recommend the confirmation of the reappointment of Lani Ewart to the Commission to Promote Uniform Legislation.

As a member of the CPUL, Lani acts as a representative of the State of Hawaii to the Uniform Law Commission, the national organization responsible for drafting many of the uniform laws enacted in Hawaii and other states throughout the country.

Lani has been a member of the CPUL since 1977. As is the case with all other Commissioners, she receives no compensation for her time. Yet she freely and enthusiastically gives many, many hours of her time in service to her position. She has served on the Executive Committee of the national organization, raising both the profile and the stature of the Hawaii delegation. She has sat on drafting committees, which do the "heavy lifting" of drafting proposed uniform laws for approval by the national organization and later by the states. Further, because the State of Hawaii has sometimes had limited or no funds in its budget to pay for travel expenses, Lani has in the past utilized her own resources to attend the annual conference of the national organization, representing the State of Hawaii. Please be assured that this conference is a working conference, and its attendees spend each day in plenary meetings or committee meetings, during which various uniform laws are considered, discussed, and worked on.
