Dear Honorable Chair and Committee Members,

Aloha, my name is Lori Buchanan and I am humbled by the appointment to the Legacy Lands Conservation Commission by our Honorable Governor Abercrombie. I come before the Senate Committee on Water and Land as part of the confirmation process and am happy to provide the following responses to your questions.

1. Why do you wish to be a member of the Legacy Land Conservation Commission? This appointment to LLCC will be my second appointment to this Commission. I was first

appointment to the Honorable Governor Linda Lingle in 2008. My initial interest in serving on the commission back then is the same as it is now, to help save important cultural, agricultural, historical, natural and recreational lands of Hawaii nei in perpetuity.

2. How do you perceive the role and responsibilities of a member of the Legacy Land Conservation Commission?

I perceive the role and responsibilities of commissioners to the LLCC to be informed members of the perspective they represent, and to do their due diligence in reviewing and validating projects applying to receive funding. As commissioners, our responsibility is to be familiar with federal, state and county laws and regulations with reference to the LLCC program. Commissioners have a responsibility to ensure that monies set aside by the state to the LLCC are used intelligently and wisely to the highest value possible.

3. Given your understanding of the role and responsibilities of a member of the Legacy Land Conservation Commission, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Legacy Land Conservation Commission.

This is the hardest question for me to answer because it asks the appointee to "toot your own horn", something I admittedly have never been comfortable with and will never be comfortable doing. In my responsibility to honored committee members and the public I submit that I believe my past experiences having already served on the commission for the past several years, have further strengthened my decision-making skills and abilities I can offer to the LLCC.

I have served 2 terms (10 years) as Chair and Vice-Chair of the Molokai Planning Commission where I immersed myself in learning about Special Management Area law and Coastal Zone Management law. With that responsibility I became familiar of the county charter and ordinances, state land use law, and federal overriding authorities. I was tasked with the final authorization of all projects proposed in those areas.

I humbly served for many years as a trustee for a private school whose focus was on sustainability and the environment.

I have participated in official consultations at the federal, state and county government level including the Department of Defense.

I have been or are currently a member of several community-based organizations over a wide spectrum of areas of interest.

For the past 10 years I have been the lead person for invasive species issues on Molokai and for the past nine months managed the invasive species committee on Hawaii Island. Most of my professional career has been working in conservation and I have developed relationships across broad and diverse sections of conservation work.

I have spent most of my life in service to the public and find being a community advocate the most rewarding part of my life.

4. What do you hope to accomplish during your term of service?

During my term of service I hope to see the promulgation of rules created by the LLCC. I hope to see rules and protocols adopted for the distribution of management funds. I hope to approve funding for awesome community based and supported project!

5. Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Legacy Land Conservation Commission?

A few qualities I hope describe me are passionate, committed and diligent. I believe the broad spectrum of issues related to the LLCC program most certainly would benefit from someone possessing those qualities. Much of the due diligence associated with the application paraphernalia, site inspection and applicant testimony call for persons of review that are passionate about protecting cultural, historical, natural and recreational land value. Persons who are very committed to go beyond submitted physical documents to search for feedback. And persons of diligence, committed to doing the homework and analysis needed to ensure that the best possible projects get funded.

6. Name one previous experience that would make you stand out? How would this benefit the Legacy Land Conservation Commission?

A previous experience transpired when an applicant went on record to state that their purpose for the land purchase/easement was to ensure the easement holder would secure access to areas with scientific and cultural values. The applicant also stated that the areas of scientific and cultural values did indeed hold items of cultural significance but that the intent was for exploration and protection and cultural items of significance would not be disturbed. I went on record in opposition based on several factors drawing on my knowledge of my fiduciary duties and responsibilities concerning our state constitution and statutes. I believe my input on record was helpful and transparent and I believe set precedence that LLCC projects must be scrutinized to the fullest possible extent to ensure that the protections afforded in our constitution/statutes are met.

7. Can you foresee any possible conflicts of interests that could arise during your service on the Legacy Land Conservation Commission? How would you overcome any possible conflicts of interest?

I do not perceive any conflicts of interest to occur however, should they arise I would choose the side of caution and recuse myself from a decision making vote. I may reserve the right to participate in discussion if I felt that it would be pertinent and helpful. I believe ensuring the overall integrity of the LLCC is one of the most important overarching goals of a commissioner. All Boards and Commissions of government should be held to the highest scrutiny in their decision making processes and commissioners and members need to work to ensure a transparent process.

In consideration of GOVERNOR'S MESSAGE 669 – SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE LEGACY LAND CONSERVATION COMMISSION, GUBERNATORIAL NOMINEE, LORI BUCHANAN, FOR A TERM TO EXPIRE 6-30-2016.

The Department of Land and Natural Resources (Department) strongly supports Governor's Message (GM) 669, nominating Lori Buchanan to the Legacy Land Conservation Commission for a term to expire June 30, 2016.

Pursuant to Section 173A-2.5, Hawaii Revised Statutes (HRS), the Legacy Land Conservation Commission (Commission) shall: 1) Advise the Department and the Board of Land and Natural Resources (Board) on any proposal, public or private, for the acquisition of any interests or rights in land having value as a resource to the State; 2) Advise the Department and the Board on any requests for grants from the fund to a qualifying state or county agency or nonprofit land conservation organization for the preservation of lands having value as a resource to the State; 3) Recommend to the Board the acquisition of interests or rights in certain lands having value as a resource to the State; and 4) Review and adopt rules relating to the criteria it applies in advising the Department and the Board and making recommendations to the Board regarding land acquisitions and grants made pursuant to Chapter 173A, HRS.

Ms. Buchanan is a resident of Moloka'i and an active member of The Nature Conservancy. For the past nine years, she has served as a field and outreach technician for the Moloka'i/Maui Invasive Species Committee. During that time, she worked with state, county and federal partners to coordinate, and carry out invasive species control on Moloka'i. Previously, Ms. Buchanan served five years as the Chairperson of the Moloka'i Planning Commission. During this time, she developed expertise in land use law and policy. Ms. Buchanan's past experiences as a trustee and teacher at two Moloka'i schools, and her heavy involvement in community organizations and activities connect her to the Moloka'i community. For the past four years, Ms. Buchanan has been a dedicated member of the Commission and has used her planning and conservation knowledge to develop and advance the Commission and Legacy Land Conservation Program. The Department strongly supports GM 669 and is appreciative of Ms. Buchanan's continued service as a member of the Legacy Land Conservation Commission.
