Dear Chair Hee, Vice Chair Shimabukuro and Members of the Committee:

The GCA is an organization comprised of over six hundred (600) general contractors, subcontractors, and construction related firms. The GCA was established in 1932 and is celebrating its 80th anniversary this year; GCA remains the largest construction association in the State of Hawaii whose mission is to represent its members in all matters related to the construction industry, while improving the quality of construction and protecting the public interest.

GCA is in **support** of GM 675, the nomination of Donald Gentzler to serve on the Hoisting Machine Operators Advisory Board (HMOAB). Mr. Gentzler has extended experience as an operating engineer both in the field and in administration. His hands on experience as well as technical knowledge about crane safety make him an excellent candidate for this position.

The Hoisting Machine Operators Advisory Board (HMOAB) was created in 1998 by the Hawaii State Legislature to focus on public and worker safety in the certification of hoisting machine operators. The HMOAB developed and adopted Chapter 12-48 (HAR), Hoisting Machine Operators, which became effective on December 6, 2002. Under these rules, certification is required for operators using equipment covered by American Society of Mechanical Engineers (ASME) B30.5 Mobile and Locomotive Cranes, having a lifting capacity of more than five tons and that are used to perform construction work as defined by Section 12-50-2 HAR. The rules require operators to show that they have the experience, training, qualifications and certification to safely operate these hoisting machines. Enforcement of this requirement is covered in Section 12-136.1-2 HAR.

The HMOAB and its members play an important role in the construction industry and their involvement has a broad affect on the health and safety of the public. Mr. Gentzler's experience and commitment to safety will make him a valuable member to this board.

GCA <u>supports</u> GM 675 and the appointment of Donald Gentzler to the HMOAB. The GCA respectfully requests this Committee confirm his appointment.
