My name is Gavan Daws. I am pleased to have the opportunity to submit testimony in support of Governor Abercrombie's nomination of Sherman Warner to the commission of the State Foundation on Culture and the Arts.

My perspective is based on more than fifty years of observation and participation. I knew Alfred Preis, who was responsible for bringing the Foundation into existence, and I had conversations with him about his ideas at the time. As for my own involvement: I have received the Hawai'i Institute for Public Affairs Award for Arts and Culture; the Hawai'i Award for Literature; the Hawaiian Historical Society Centenary Distinguished Historian Award; and the Hawai'i Book Publishers Association's Lifetime Award. I am a co-founder of MELE, an educational program that teaches the business of music and entertainment, now in its eighth year at Honolulu Community College. My documentary films have been shown at the Hawai'i International Film Festival. Beyond Hawai'i, I have been awarded fellowships by the National Endowment for the Arts and the National Endowment for Humanities, and I served as the Pacific member of the UNESCO Commission on the Cultural and Scientific History of Humankind.

I have a brief general observation to make about arts and culture in Hawai'i in the twenty-first century--

Hawai'i is uniquely Hawai'i. And the same time, Hawai'i is inextricably connected with the wider world.

So, the challenge is: how to nourish and sustain cultural and artistic creativity that draws its identity, its inspiration and its vitality, from life in Hawai'i?

At the same time, there is unlimited opportunity to draw upon the wider world of culture and the arts, to tap into national and global experience and wisdom, to bring best practices here and get them to work in local conditions-to the benefit of Hawai'i.

This brings us to Sherman Warner.

Sherman is locally grounded: he was born and raised on the Big Island, and he is a graduate of UH.

He went on to make a distinguished and highly successful national career in theater–a career that I have followed with great interest and admiration.

That career covers three decades and a wide range of experience, from freelancing in a variety of situations, to working as a producer in prestigious non-profit venues in New York (the Public Theatre Shakespeare Festival and the Brooklyn Academy of Music), and then to being a founding partner of Dodger Productions, one of the most successful producers of Broadway musicals, with an outstanding track record of more than two dozen major productions and four Tony awards. (On a personal note, it has been a recurring pleasure for me when visiting New York to be able to take in shows of Sherman's.)

In the truest sense of the phrase, Sherman has professionally "been there and done that," dealing repeatedly and successfully with complex issues of artistic vision, large-scale logistics, and real-world viability.

In addition to musical theater, he is greatly knowledgeable about music generally, and about developments in the visual and plastic arts, nationally and globally.

In 2002, Sherman came back to Hawai'i, to live on the Big Island. For the last decade, he has been productively active in a number of community organizations, both as a hands-on volunteer and in leadership roles.

Summing up: he has achieved great professional distinction in the world of theater; he is at very much at home in the wider world of arts and culture; and he is a good and useful citizen of Hawai'i.

In my view-as a candidate for appointment to the commission of the State Foundation on Culture and the Arts, Sherman Warner offers exceptional value.

Statement from Sherman Warner Nominee to Hawai'i State Foundation on Culture and the Arts Commission

(1) Why do you wish to be a member of the State Foundation on Culture and The Arts Commission?

I feel richly rewarded by the community work I have done since retiring a little more than ten years ago, but combining volunteer service with two things that I love deeply—art and Hawai'i—is an opportunity that I would gladly commit myself to.

Although it took me away from Hawai'i, a career in the professional theatre gave me the great good fortune to live in New York City, where, in addition to theatre, I could immerse myself in the seemingly endless resources of other art scenes dance, music, and the visual arts. I still visit New York and San Francisco a few times a year and spend as much time as possible in museums and galleries or attending plays or concerts, but it is the arts of Hawai'i, with their unique sense of place and their cultural and ethnic diversity, that just feel like home to me.

From my first exposure to the arts—a drawing class at the Honolulu Academy of Arts when I was 8 or 9 years old, or attending Honolulu Symphony concerts with my grandmother—through my study of literature and theatre at the University of Hawai'i, exposure to the arts changed my life. Playing a small part in supporting the arts in Hawai'i would be a way to pay back what the arts have given me.

(2) How do you perceive the role and responsibilities of a member of the State Foundation on Culture and The Arts Commission?

I believe that the role of a member of the State Foundation on Culture and The Arts Commission is to support the goals stated in the SFCA mission statement, to evaluate whether those goals are being most effectively carried out with the available resources, and, periodically, to revise or amend those goals.

(3) Given your understanding of the role and responsibilities of a member of the State Foundation on Culture and The Arts Commission, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the State Foundation on Culture and The Arts Commission.

Working as a producer and general manager in the Broadway theatre, my skills allowed me to combine functions commonly handled by different people or offices. Most producers hire managers to handle the business side of mounting a new production. In addition to working with my two partners on the creative and strategic side of producing, I created and managed budgets in excess of \$10M and was deeply involved in the technical production aspects of mounting large, complex productions. I was proud of my reputation for handling these managerial roles while being respected by the creative staff for being their best advocate and enabling their best work. I think I was successful because I could facilitate a high-pressure decision making process in which all parties (creative, technical or financial) supported the outcome.

I also served many times as a negotiator representing our multi-employer trade association in negotiations with the industry's major unions. One unusual aspect of these negotiations was that while I was bargaining for the employers' side, I was a member of one of the unions (actors and stage managers) and had worked in the jurisdiction of two others (stage hands and managers). Like producing, being successful in negotiations involved getting the parties to set aside their positions and identify their interests. I served often on union grievance committees, not only because of my knowledge of the contracts and past practices, but also because I had working experience under those contracts.

Except for rare occasions, such as when my firm was hired by Walt Disney Corporation to general manage their first venture on Broadway, I was always my own boss in a business where success depends on being a passionate, stubborn advocate for unique, outside-of-the-box ideas at the same time that you need to be a team builder in a world major talent and ego.

Finally, as a trained mediator and president of the board of the West Hawai'i Mediation Center, I have worked to help parties resolve seemingly irreconcilable differences by finding constructive solutions.

(4) What do you hope to accomplish during your term of service?

As a representative from an outer island, I will advocate for visibility and support of the arts in places where we lack the artistic resources of Oahu. On the Big Island, for example, the Kahilu Theatre, one of our principal performing arts centers, has taken an "intermission" and is struggling to re-open. Its closing not only deprives audiences of an opportunity to experience the performing arts, it also shuts down an outreach program that reached thousands of Big Island children. I believe that the current emphasis on standardized testing and "teaching to the test" has diminished the role of the arts in our schools; that role needs to be protected and expanded. Finally, I want to explore whether we are maximizing the display opportunities for artworks in the State's collection. I believe that State of Hawai'i's art collection should have an online presence—a publicly accessible, searchable, curated, online, virtual museum.

- (5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the State Foundation on Culture and The Arts Commission?
 - 1. Open-mindedness

- 2. Integrity
- 3. Belief that creativity and the arts are a measure of the wellness of a society

I believe that the SFCA Commission would share these qualities and that by having them I would fit in smoothly rather than stand out.

(6) Name one previous experience that would make you stand out. How would this benefit the State Foundation on Culture and The Arts Commission?

This is the hardest question of all as it has never been my goal to stand out. I can work tirelessly for the success of a project I'm involved in and then, quite happily, step away from the limelight, letting credit go to others. If there's an experience that makes me stand out (at least in my community), it's the decision, ten years ago, to do in retirement what I could never do while I was working—community service. Very long workdays, seven-day work weeks, an unpredictable schedule, and travel precluded community service while I was working. So, the standout experience was the decision I made shortly after retiring that although I could spend my retirement paddling, diving, fishing, biking, hiking, and traveling, a substantial part of my retirement had to be committed to service. The SFCA Commission would benefit from this decision not just because of my interest in public service but because my commitment would be heightened by a sense of debt, the sense that I owe a debt of gratitude to the arts for making so much of my life, my career, and even my retirement possible.

(7) Can you foresee any possible conflicts of interests that could arise during your service on the State Foundation on Culture and The Arts Commission? How would you overcome any possible conflicts of interest?

A conflict of interest that I can imagine might involve the acquisition, commission, or display of art by a friend or acquaintance. If that situation were to arise, I would immediately make the possibility of a conflict known and recuse myself.
