Chair Taniguchi, Vice-Chair Kahele and members of the Committee on Higher Education, thank you for the opportunity to appear before you today.

I wish to thank Governor Abercrombie for nominating me to another term. I consider it an honor and a privilege to be considered as a Regent of the University of Hawaii. Also, a big mahalo to everyone who submitted letters of support on my behalf.

Chair Taniguchi requested written responses to some very comprehensive questions to which I have complied, thus will not repeat myself.

I have been serving as a Regent since August of 2011, and was confirmed for a one-year term starting July 1, 2012.

Both my parents only completed the 8th grade and went to work to help support large families. My parents struggled financially, but insisted that their children would go to college, no ifs ands or buts. The three siblings did in fact go to college and each pursued different professional paths.

My parents understood the value of higher education and the many opportunities for a better lifestyle. I share this value with my parents and would like to contribute my time and effort to help keep the University of Hawaii System one of the finest institutions of higher learning while allowing future generations of "rubber slipper" folks like me to open new opportunities for a better life.

The University of Hawaii System is very important to everyone in the State and must continue to offer a quality education to our students at an affordable price. A goal of the University is to have 55% of Hawaii's working age population with a college degree by 2025. This can only be achieved by maintaining the financial viability of the System by thoughtfully balancing our expenses with the various revenue sources, including tuition and fees. The University must maintain a healthy balance sheet.

I am a CPA by profession, and have spent 43 years in the field of accounting/finance, energy, and management in the private and government sectors. The last 22 years in the renewable energy field, with primary focus on geothermal energy. I previously served Hawaii County as managing director and finance director under two mayors, and served as CFO of Hamakua Sugar Company with Franny Morgan. Prior to moving to Hawaii Island, I had various management positions with TheoDavies, Hawaiian Electric, and Deloitte & Touche. I retired at the end of 2012.

Being a member of our community, I am currently involved with several non-profits or volunteer groups, including the Hawaii Island Chamber and the Japanese Chamber of Commerce, Hawaii Island Economic Development Board, Hawaii Leeward Planning Conference, Mayor's Health Care Task Force, and Hilo Hongwanji. I co-chaired the \$10 million community capital campaign for a new Hospice of Hilo in-care facility. I am a strong proponent of giving back to the community.

In closing, I would like to thank the Committee for the hard work you do for our benefit and for giving me the opportunity to testify today. Thank you for considering my nomination.
