At Catholic Charities Hawaii, I administered housing assistance programs for the elderly and homeless families. My work with housing, aging, and homeless coalitions have given me insight into the needs of the people who will reside in the affordable housing projects promoted by HHFDC. On the other hand, I know the challenges of producing affordable housing projects from my service on the boards of two non-profit housing corporations. These experiences help me to understand and balance sometimes competing needs in the decision making process to award funding at HHFDC.

Having worked with the legislature and other advocates in the 1990's to establish the Rental Housing Trust Fund. I also have a long history in advocacy to promote affordable rental housing. I am also an advocate to create an inventory of affordable housing that remains affordable for the longest period of time that is reasonable. This inventory of stable rental housing is critical for the State to reduce homelessness and provide adequate housing for our lower-income residents.
