Chair Hee and members of the Committee on Judiciary,

Thank you for the opportunity to testify.

I would like to thank Governor Neil Abercrombie for nominating me, and deem it an honor to be considered as a member of the Commission on the Status of Women.

I would also like to thank those who submitted testimony in favor of my nomination.

I have lived in Hawaii for 33 years, and was married to my late husband, who was born and raised here, for 45 years. I raised my four children here, and have lived at the same address in Mililani Town for 33 years.

I am a graduate of the Syracuse University School of Nursing, and began my nursing career in the United States Navy. I also served as Nurse for the American Institute in Taiwan where my husband was assigned as a Foreign Service Officer.

I was employed at Wahiawa General Hospital for 25 years, serving as manager of the Medical Surgical Unit, and Nursing Supervisor. In 1995, I wrote and defended a certificate of need creating a Medicare Certified Home Health Agency, which is still serving the community.

I have been very active in the community, and have served as Chair of Neighborhood Board 25, President of the PTSA, served on SCBM and SCC committees, and many other community groups.

I was elected to the Legislature in 1996, and served 16 years.

During my Legislative career, I served as Majority Floor leader, and later as Vice chair of the Committee on Finance, as well as several other Committees. I served as Co-Chair of the Women's Legislative Caucus for most of my years in the Legislature, and worked closely with many women's groups in the community, and with my counterparts in the Senate. I also served as co-chair of the Kupuna Caucus for many years.

I was elected as President of the Women's Network of the National Conference of State Legislatures. I was also selected as a Fleming Fellow, traveling abroad to Japan and China under their auspices to interact with women leaders. I was also selected to attend the Foreign Policy Institute of the Center for Women Policy Studies in Washington, DC.

Since leaving the legislature, I have been appointed to the Neighborhood Board 25, and was appointed by the Mayor to serve on the CDBG committee. I was also recently appointed to the Board of the Missing Children's Center.

I continue to serve as a member of the Board of the Friends of Mililani Public Library, President of Central Oahu Caregiver Support Group, and am active in Soroptimists and Lions. I am dedicated to improving the status of Women and girls in our community, and in helping to educate the community at large about the needs of this community. I am especially interested in the needs of women approaching retirement age, who have served as caregivers and subsequently lost their spouse. Many suffer in silence from financial distress, and isolation. This population has not received sufficient attention in our state. On the other hand, I am passionate about educating the young about the history of women's rights in Hawaii and the nation.

I believe my experience and interests will be an asset to the Commission on the Status of Women and to the State of Hawaii. My heart is in Hawaii, and I intend to remain here for the rest of my days.
