1 Department's Position: The Department of Health (DOH) supports the confirmation of Kurt Nagata to

2 serve on the Mental Health and Substance Abuse, Kauai Service Area Board (KSAB) for a term to

3 expire June 30, 2016.

5 **Purpose and Justification:** The purpose is for the consideration and confirmation of Gubernatorial

6 Nominee, Kurt Nagata. Pursuant to Chapter 334-11 of the Hawaii Revised Statutes on Service Area

7 Boards, the members of the Service Area Board are service area residents who are consumers or non-

8 providers of mental health services and service area providers with a majority being non-state employees

9 and non-providers of mental health or other health services.

10 **Kurt Nagata (G.M. 736),** a consumer representative, is the newly elected President of the Board

of Directors of Friendship House on Kauai, Hawaii's first Clubhouse in the State. Mr. Nagata has been

12 an active member of Friendship House for several years and was also a member of the Consumer,

- 13 Family and Youth Hui (CFY). As a Kauai CFY leader, Mr. Nagata assisted in organizing consumer
- 14 conferences, arranged for speakers and coordinated the logistics for these conferences. Mr. Nagata is an

2	sharing his life experiences with mental illness with his peers and the community. He often emcees
3	formal community events for Friendship House.

5	focused. He engages very easily with potential members of the Clubhouse and is always looking for
6	opportunities to encourage consumers to become more involved in Clubhouse activities. Along with his
7	many accomplishments, Mr. Nagata is a Wellness Recovery Action Plan (WRAP) facilitator, where he
8	trains other consumers in developing their own WRAP. Mr. Nagata is a strong advocate for consumers
9	and will be a valuable asset to the board.

Today I have an attitude that I am grateful for what I have, and not for what I don't have.I was invited to on the Kauai Service Board for mental health and substance abuse. In the moment I am wanting to take the commitment.

I believe I would make a great addition to the board because I have many years of recovery under my belt. I like helping others. And working with others is what I am good at also.
