Dear Senator Tokuda:

Re: GM 751 - Nomination to the Hawaii Teacher Standards Board

Thank you for scheduling my nomination by Governor Neil Abercrombie to the HTSB.

As you requested, the following captures the questions you have asked of me and my responses accordingly:

(1) Why did I decide to apply to serve on the HTSB?

I am requesting reappointment to the Board as the public member because I believe I have and can continue to be a contributing member. I also enjoy this form of public service.

(2) Given my understanding of the role and responsibilities of a member of the HTSB, why do I believe that I am qualified for the position? (Include a brief statement of the skills, expertise, experiences, or knowledge that would aid in my decision-making ability as a member of the HTSB. Highlight the three qualities that make me a highly qualified candidate.)

With 20⁺ years of experience as the former administrator of a State regulatory professional and vocational licensing entity I bring to the HTSB familiarity with working with laws, rules, licensing and regulation, client service, budgeting, streamline and efficient processing, legislation and rule making, and working cooperatively with boards and constituencies. This provides a sound foundation for me to be an effective board member. I would describe myself as reasonable and practical, dedicated to doing any job well, and a proficient problem solver.

(3) What do I perceive the role and responsibility of the HTSB is as it relates to teacher quality and student achievement?

We have a role in determining teacher quality for new licensees by ensuring the quality of their teacher preparation program provides clinical studies and practical experiences that are relevant to today's needs and that the program completer graduates with the capabilities and confidence to perform effectively in the classroom. > accordingly with the teacher preparation programs. We also have a role in ensuring that with re-licensure (also known as license renewal), the licensee has maintained a level of competency and professionalism to continue to be an effective teacher in the classroom. Our responsibility is selecting what would best demonstrate this standard and to re-license accordingly.

> While I do not believe the Board has a direct role on the matter of student achievement there is no doubt that the above described roles and responsibilities, if done well by the Board, can positively impact teacher effectiveness and thereby be a factor for student achievement.

(4) Because of long-standing legislative concerns, the HTSB was audited by the State Auditor in 2009. Especially serious was the negative perception of HTSB by those it served and with those it worked with. What progress has been made during my tenure and what more could or should be done to improve the perception and effectiveness of the HTSB?

In my opinion, the Board has made great strides in improving its licensing services and communications with its constituency. It has also become much more transparent in the conduct of its business and engages stakeholders for input and recommendations. It also has become fiscally responsible. The relationship with the Department of Education has improved. The Board has also worked at being part of the solution (rather than the source of the problem), thoughtful and deliberate in its discussions, mindful of the parameters of its regulatory law and rules, and considerate of the impacts that could result from their decisions. Continuing to improve in all these areas should and is being done.

(5) Do I foresee any possible conflicts of interests that could arise during my service on the HTSB? How would I overcome any possible conflicts of interest?

No conflicts are foreseen at this time but should any arise I will fully disclose this to the Board and recuse myself from discussions and decision-making.
