I am writing in enthusiastic support of the gubernatorial nomination of Dr. Mae Mendelson to the Policy Advisory Board for Elderly Affairs. I have known Dr. Mendelson for over 2 decades and have been most impressed with her long, dedicated and creative commitment to elder care issues in Hawaii, in the U.S. and the world. Dr. Mendelson has many years of experience that she can bring to this position. She has a long history of working in the Hawai'i's non-profit community, creating and implementing health and social services programs for Hawai'i residents. For example, she was Director of Development for the YWCA, Community Planner and Program Director at Hawai'i Community Services Council (HCSC), Program Developer for Elderhostel, and Executive Director of the Hawai'i Intergenerational Network.

She also has worked in academia, teaching classes at Hawai'i Pacific University and at the School of Social Work, University of Hawai'i Manoa.
