Chair Espero, Vice Chair Baker and Members of the Senate Committee on Public Safety, Intergovernmental and Military Affairs:

Thank you for providing the Crime Victim Compensation Commission (the "Commission") with the opportunity to testify before you today. The Commission strongly supports the appointment of Abelina Shaw to serve as a Commissioner for a term to expire on June 30, 2017. Ms. Shaw is an experienced legal advocate and has served our community in various capacities for many years, including in the legislative, executive and judicial branches of government. Ms. Shaw's contributions to the community have also been recognized by the Filipino Association of University Women, the United Filipino Council of Hawai'i, and the Filipino Women's Civic Club among others.

The Commission is a quasi-judicial body that assists victims of violent crime by providing compensation for crime-related expenses. The Commission also administers a Restitution Recovery Project to collect restitution from inmates and parolees and disburse the funds to crime victims. Commissioners hear appeals from administrative decisions ordering or denying compensation, and set policy for the determination of claims submitted to the Commission. A special area of concern for Commissioners has been the treatment of sexual assault and domestic abuse victims, and the fiscal self-sufficiency of the Commission.

> Commission appeals are heard de novo. Commissioners determine eligibility, and evaluate and analyze criminal justice data to verify that an eligible crime has occurred. Commissioners also analyze and evaluate financial, medical and criminal justice documents. The most difficult decisions issued by the Commissioners are those that limit or deny compensation awards. These decisions are difficult because they involve an assessment of the extent to which the claimant may have contributed to the incident that cause their injuries or death.

> It is important that these decisions are fair, clear, and consistent. Each claim that is limited or denied must be distinguished on its facts from other cases where compensation awards are granted in full. Relevant statutes, rules, and guidelines must be applied to the facts and analysis conducted to determine whether the claim should be granted, limited or denied. In this regard, Ms. Shaw's experience as an attorney, demonstrating a keen knowledge and understanding of applicable federal and state laws, rules and guidelines, as well as her ability to interpret complex material and resolve problems logically and consistently, will be an asset to the Commission.

Victims of violent crime who apply for compensation are often traumatized and angry about what happened to them and frustrated about the way the criminal justice system treats victims. Commissioners must be sensitive and compassionate in dealing with these individuals. Ms. Shaw's service with community organizations such as Aloha United Way, Hale Kipa, Safe Haven, the Family Treatment Services Advisory Council, and the Kapiolani Hospital Health Foundation indicate that she has the requisite breadth of knowledge, compassion, and skill to assist victims of crime who come before the Commission.

Another area of commitment for the Commission is improving the delivery of compensation services to underserved victim populations. The Commission was part of a strategic planning project to develop a strategic plan to address the needs of underserved populations. The project identified the elderly, individuals with limited English language proficiency, the disabled, and visitors/tourists as underserved victim populations here in the state. Throughout Ms. Shaw's collective experiences in governance, she has advocated for human service initiatives that seek to address the needs of the socially disenfranchised and underserved in our community, and provide greater access to government services for all of Hawai'i's citizens.

Ms. Shaw's background and experience will be invaluable to the Commission in its efforts to serve Hawai'i's victims of violent crime. The Commission therefore urges you to confirm Ms. Shaw's appointment to the Commission.
